

## State Document Processing Times for Limited Liability Companies (LLC)

The table below shows the standard processing time and the rush express processing time. Please note that all times stated represent the average turnaround time and can vary throughout the year. Typically, state offices slow down from the beginning of December until the beginning of March due to the large amount of LLC formations that are filed. Document filing agencies observe all federal and state holidays which can add to the time it takes for your document to be processed.

**Business days are Monday through Friday and exclude weekends and holidays.** For faster service, please purchase the *FedEx –To and From the State* at check out time. Otherwise, your document will be mailed to and from the state filing agency via the US Postal service which can add a significant amount of time to the filing process.

Due to the lengthy turnaround time, all California filings will be processed on a rush basis. Note: We are able to process California documents in 24-72 business hours for an additional \$500.00 service fee plus state filing fees. Please contact us before placing your order to discuss rush filing options in California.

\*\*Arizona's standard processing times are so long (16-20 weeks) that we only offer the standard express rush package for Arizona Incorporations.

\*\*\*Although Maryland's standard processing times are very long (10-12 weeks), our customers have the option to file using our standard service. Please note that it will take at least 10 weeks (2 ½ months) for your document to be filed. We highly recommend that you utilize the rush options for Maryland.

Turnaround times do not include the time it takes to check name availability, prepare the document, mail the document to and from the state agency, and mail the document to the customer. Depending upon the state filing agencies, turnaround times can change at any time. Most state filing agencies are controlled by an elected official. During election times and depending upon the outcome of the election, filing times can increase or decrease.
